Two upcoming projects, the Public Art Master Plan RFP and the Public Art Projects in Fargo RFP, will require additional review by sub-committees of the Arts and Culture Commission prior to review and recommendation by the Arts and Culture Commission as a whole. At the October 21st Arts and Culture Commission meeting, it is asked that the commission select sub-committee members to review these proposals. Sub-committee meeting dates and times will be arranged by staff at a later date.

Attached for your review is an outline of the selection process for both RFPs, as well as schedules for November of 2015. These schedules outline the time frame which these projects need to be reviewed and approved.

**Public Art Master Plan Selection Committee**

In July of 2015, the Arts and Culture Commission approved a Request for Proposals for Consulting Services for a Public Art Master Plan. On September 28<sup>th</sup>, City Commission approved the RFP which was subsequently issued on October 1<sup>st</sup>.

The RFP stated that a selection sub-committee consisting of four members of the Arts and Culture Commission would provide primary review of the submittals. These four members need to be selected.

In Addition to the regularly scheduled Arts and Culture Commission meeting, it can be expected that sub-committee members will need to dedicate an additional 4-5 hours in November to review proposals and conduct interviews.

**Public Art Projects in Fargo RFP Selection Committee**

The Public Art Projects in Fargo RFP was approved by the Arts and Culture Commission at its September meeting. The RFP is tentatively scheduled to be published between October 16<sup>th</sup> and the 20<sup>th</sup>. The RFP designates a selection sub-committee of the Arts and Culture Commission to serve as the review committee for this proposal. The commission needs to designate how many members will serve on the sub-committee and who those members will be.

In addition to the regularly scheduled Arts and Culture Commission meeting, it can be expected that sub-committee members will need to dedicate an additional 1-2 hours in November to review proposals.
